"As a woman of faith, dedicated to educating and advocating for women and girls of color, poor women and rural women, I find H.R. 36 not only out of step with the foundations of my Christian beliefs, but clearly inflexible pseudo moralistic paternalism on the part of legislators. Your insistence on maintaining your position is dangerous as women and girls, with various life and medical circumstances, require abortion-care as part of their well-woman care. If your job is truly dedicated to upholding the tenets of human rights, then women have spoken for ourselves, our families and our communities. "Attempts like this to ban abortion are a red herring. They reinforce negative stereotypes about women who seek abortions and they detract from the very real need to address the reasons that women cite for terminating their pregnancies. "It is strange to see those opposed to the Affordable Care Act on the grounds that it was inserting the government between you and your doctor continue to draft legislation that explicitly does this very thing in specific circumstances.
