Note: The U.S. State Department has published data on passports issued by states for the last five years through Fiscal Years (FY) 2020-2024. In order to provide an estimate of the number of valid passports in circulation that could be used to prove citizenship under the SAVE Act, data for years FY 2014-2025 was needed. To get data for FY 2014-2019, the average share of total passports issued nationwide between FY 2020-2024 was calculated for each state. For example, on average, between FY 2020-2024, West Virginia issued 0.22% of passports nationwide. This ratio was used estimate how many passports were issued during those years. For example, for FY 2019, the State Department reported that 17,794,977 passports were issued nationwide. For the purposes of this analysis, it was estimated that West Virginia issued 0.22% of those, or 39,023. Data for FYs 2015-2019 was calculated using this methodology. As children who are citizens also includes children. Therefore it is accurate based on this data to say for example, only 20.7% of West Virginia citizens possess a valid passport issuance rate for each state and the reported number of passports issued nationwide.

Note: According to a survey conducted by the Pew Research Center, 79% of women in opposite-sex marriages have changed their surname to their spouse's while 5% hyphenated their surname, meaning that 84% of women who are currently or have been in opposite-sex marriages have changed their legal name and therefore do not posses a birth certificate that could prove their identity and by extension citizenship status under the SAVE Act. Data on the number of women who have changed their surname back to their maiden name following a divorce or seperation is not readily available publicly and for the purposes of this data, all women who have reported being married at some point were taken into account for estimating the number of women whose legal name has been changed from their maiden name. Additionally, as reported by Pew, the number of men and women in same sex marriages were too small of groups to analyze seperately for name-change data. For the purposes of this analysis, all married couples were treated as opposite sex marriages to estimate the number of women who have changed their name due to marries. While some of the couples used for this analysis are in fact in same sex marriages, many of those individuals have also changed and hyphenated their name so it is not innacurate to also include as of 2021, compared to approximately 710,000 same-sex marriages nationwide as of 2021, compared to approximately 62 million married couples nation-wide meaning that same-sex married couples account for only 1.1% of married couples nationwide. Using data from the American Community Survey, the total number of currently married, divorced or seperated, and widowed citizens 15 years or older was calculated based on data available seperate for native born citizens and naturalized. The total number of individuals was then halved to account for half of the women in these presumed opposite-sex couples. These findings based on ACS data can be found in column C. Based on this data it would be accurate to say for example "As many as 1
